

**BACKGROUND:**

This agreement applies as between you, the User of this Website or Purchaser and JSP Limited, the owner(s) of this Website. Your agreement to comply with and be bound by these Terms and Conditions is deemed to occur upon your first use of the Website. If you do not agree to be bound by these Terms and Conditions, you should stop using the Website immediately.

No part of this Website is intended to constitute a contractual offer capable of acceptance. The Purchaser's order constitutes a contractual offer and our acceptance of that offer is deemed to occur upon our sending a dispatch email to the Purchaser indicating that the order has been fulfilled and has been dispatched.

**1. Definitions and Interpretation**

In this Agreement the following terms shall have the following meanings:

<b>“Account”</b>	means collectively the personal information, Payment Information and credentials used by Users to access Paid Content and / or any communications System on the Website;
<b>“Carrier”</b>	means any third party responsible for transporting purchased Goods from our Premises to customers;
<b>“Content”</b>	means any text, graphics, images, audio, video, software, data compilations and any other form of information capable of being stored in a computer that appears on or forms part of this Website;
<b>“Goods”</b>	means any products that JSP Limited advertises and / or makes available for sale through this Website;
<b>“JSP Limited”</b>	means JSP Limited incorporated and registered in England and Wales with company number 791380 whose principal business office is at , Worsham Mill, Minster Lovell, Oxford OX29 0TA, England (which expression shall be deemed to include any subsidiary or associated company from time to time of JSP Limited);
<b>“Service”</b>	means collectively any online facilities, tools, services or information that JSP Limited makes available through the Website either now or in the future;
<b>“Payment Information”</b>	means any details required for the purchase of Goods from this Website. This includes, but is not limited to, credit / debit card numbers, bank account numbers and sort codes;
<b>“Purchaser”</b>	means any person or business that buys Goods from JSP Limited from this Website;

- “Purchase Information”** means collectively any orders, invoices, dispatch notes, receipts or similar that may be in hard copy or electronic form;
- “Premises”** Means our place(s) of business located at Worsham Mill, Minster Lovell, Oxford, OX29 0TA;

JSP Limited is not responsible for these charges and we undertake to make no calculations or estimates in this regard. If a Purchaser buying internationally, they are advised to contact their local customs authorities for further details on costs and procedures. The Purchaser of the Goods will also be the importer of record and as such should ensure that the purchase is in full compliance with the laws of the country into which the Goods are being imported. Please be aware that Goods may be inspected on arrival at port for customs purposes and JSP Limited gives no guarantee that the packaging of the Goods will be free of signs of tampering.

## 10. Accounts

- 10.1 In order to purchase Goods on this Website and to use the enquiry facilities Users are required to create an Account which will contain certain personal details and Payment Information which may vary based upon a User's use of the Website as we may not require payment information until a purchase is to be made. By continuing to use this Website you represent and warrant that:

10.1.1 all information you submit is accurate and truthful;

10.1.2 if you are buying on behalf of your employers, you have the authority to submit Payment Information where any such authority is required; and

10.1.3 you will keep this information accurate and up-to-date.

Your creation of an Account is further affirmation of your representation and warranty.

- 10.2 It is recommended that you do not share your Account details, particularly your username and password. JSP Limited accepts no liability for any losses or damages incurred as a result of your Account details being shared by you. If you use a shared computer, it is recommended that you do not save your Account details in your internet browser.

- 10.3 If you have reason to believe that your Account details have been obtained by another without consent, you should contact JSP Limited immediately to suspend your Account and cancel any unauthorised purchases that may be pending. Please be aware that purchases can only be cancelled until they are dispatched. In the event that an unauthorised purchase is dispatched prior to your notifying us of the unauthorised nature of the purchase, JSP Limited accepts no liability or responsibility and you should make contact with the Carrier detailed in the Purchase Information.

- 10.4 When choosing a username Users are required to adhere to the terms set out above in Clause 9. Any failure to do so could result in the suspension and/or deletion of your Account.

## 11. Termination and Cancellation

- 11.1 Either JSP Limited or a User may terminate an Account. If JSP Limited terminates your Account, you will be notified by email and an explanation for the termination will be provided. Notwithstanding the foregoing, we reserve the right to terminate without giving reasons.

- 11.2 If JSP Limited terminates an Account, any current or pending purchases on your Account will not be cancelled and will be dispatched.

- 11.3 JSP Limited reserves the right to cancel purchases without stating reasons, for any reason prior to processing payment and dispatch.

- 11.4 If purchases are cancelled for any reason prior to dispatch Purchasers will be refunded any monies paid in relation to those purchases.

- 11.5 If a User terminates their Account any non-dispatched purchases will be cancelled and a full refund of any monies paid in relation to those purchases

will be paid through the payment method used when the Goods were purchased.

## 12. **Payment**

- 12.1 Credit terms may be offered subject to satisfactory credit vetting of the Purchaser. On application for a credit account, the Purchaser must complete and sign JSP Limited's credit application form and place a minimum order of £1,000. JSP Limited operates a credit insurance policy and the offer of credit will be determined by the credit insurance provider. Orders may be held if they conflict with the credit terms defined by said policy.
- 12.2 If any sum owed by the Purchaser to JSP Limited should be overdue for payment, JSP Limited may withhold any products due for delivery to the Purchaser under any contract without prejudice to JSP Limited's rights and the Purchaser's liability under such contract
- 12.3 JSP Limited reserves the right to charge interest on any amounts overdue for payment. This will be calculated at 2% greater than Bank of England base rate.
- 12.4 JSP Limited reserves the right to make an additional administrative charge to the Purchaser for costs incurred where the total value of the orders falls below the figure to be determined from time to time by JSP Limited.
- 12.5 Any and all invoices are due for payment on the date shown on the invoice, unless alternative arrangements have been agreed between the Purchaser and JSP Limited.

## 13. **Goods, Pricing, Availability, Promotions and Competitions**

- 13.1 Whilst every effort has been made to ensure that all graphical representations and descriptions of Goods available from JSP Limited correspond to the actual Goods, JSP Limited is not responsible for any variations from these descriptions. This does not exclude our liability for mistakes due to negligence on our part and refers only to variations of the correct Goods, not different Goods altogether. Please refer to Clause 16.1 for incorrect Goods.
- 13.2 Where appropriate, you may be required to select the required [size] [model] [colour] [number] [other features] of the Goods that you are purchasing.
- 13.3 JSP Limited does not represent or warrant that such Goods will be available. Stock indications are provided on the Website however these may not take into account sales that have taken place during your visit to the Website.
- 13.4 All pricing information on the Website is correct at the time of going online. JSP Limited reserves the right to change prices and alter or remove any special offers from time to time and as necessary. All pricing information is reviewed and updated on a daily basis.
- 13.5 In the event that prices are changed during the period between an order being placed for Goods and JSP Limited processing that order and taking payment, you will be contacted prior to your order being processed with details of the new price;
- 13.6 The Purchaser will have access to JSP Limited's end of line or clearance Goods. Product names, images and descriptions may be missing from these Goods. Some of these Goods may be provided in packaging that has been branded outside JSP Limited's usual packaging. This may include stock originally intended for a Third Party. Any Goods falling into this category are 'sold as seen' (listed) and any purchases made cannot be returned or

refunded after the Goods has been dispatched.

- 13.7 Promotions will be subject to their own terms and conditions specified. Flash prices and promotions can be applied or retracted at any time. Promotional codes must be used or clearly identified within the checkout process when the order is placed. Any codes or promotions will be applied entirely at JSP Limited's discretion. JSP Limited is under no obligation to fulfil any offers such as special prices or promotional codes after the expiry date.
- 13.8 At times JSP Limited may run competitions. Competition entry requirements will be stated or accessible to the Purchaser upon entering the competition. JSP Limited reserves the right to withdraw such competitions at any time. JSP Limited are not responsible for any prizes received through entering a competition and cannot be held responsible for any Goods or services provided by a Third Party, i.e. an experience day or a product not manufactured by JSP Limited.
- 13.9 All prices on the Website do not include VAT. JSP Limited's Group VAT number is GB 222 2162 61.

#### 14. **Carriage**

- 14.1 A standard carriage charge will be paid by the Purchaser for mainland UK on orders over £400. Orders below this value will incur a small order charge of £15.
- 14.2 The order may be subject to a special carriage charge which are determined by the size and shape of the Goods, e.g. Barriers, Cones, Roadbloccs and Storage Containers. You will be contacted prior to your order being process with the details of the cost of the carriage.
- 14.3 JSP Limited will not be liable for any late deliveries by the carrier.
- 14.4 Any amendments made after an order confirmation is sent may effect and delay the delivery of Goods.

#### 15. **Property, Risk and Account of Profits**

- 15.1 Title in Goods will not pass to the Purchaser until the full purchase price for those Goods has been received by JSP Limited. Title remains with JSP Limited until payment is complete.
- 15.2 If the Purchaser sells the Goods on to its own customers in any form, either as purchased from JSP Limited or forming a component part of a larger Good, and any amount of the purchase price payable to JSP Limited remains outstanding, the Purchaser must account to JSP Limited for the proceeds of such a sale. The Purchaser is then required to hold such proceeds on trust for JSP Limited until payment has been received in full by JSP Limited.
- 15.3 JSP Limited reserves the right to trace all proceeds under the principles of Re Hallett's Estate (1880) 13 Ch D 696. Once the payment date has passed, if any sums remain outstanding, JSP Limited has the right to enter the Purchaser's premises and remove any Goods which, by virtue of sub-Clause 14.1, remain the property of JSP Limited.

#### 16. **Delivery**

- 16.1 JSP Limited will notify you by way of email when your Goods are to be dispatched to you. The message will contain details of estimated delivery times in addition to any reasons for a delay in the delivery of the Goods purchased by you.

- 16.2 If JSP Limited receives no communication from you, within 14 days of delivery, regarding any problems with the Goods, you are deemed to have received the Goods in full working order and with no problems.
- 16.3 Each delivery shall be considered a separate transaction and the failure of any delivery shall not affect the due performance of the order. Every effort will be made by JSP Limited to deliver the Goods within the agreed delivery period but no guarantee of delivery date is implied and JSP Limited shall not be liable for loss of damages occasioned by any delay in delivery.
- 16.4 Where the Purchaser fails to accept deliveries in accordance with the terms and conditions of the order, the balance of the undelivered products shall be invoiced to the Purchaser, the Goods being held at the Purchaser's risk and any storage and additional carriage costs being charged to the Purchaser's account.

## 17. **Goods Returns Policy**

JSP Limited aims to always provide high quality Goods that are fault free and undamaged. All Goods are sold on a firm sale basis, i.e. JSP Limited will not take back any Goods not required or sold by the Purchaser, unless otherwise agreed in writing. JSP Limited will only accept returns that appear in JSP Limited's current Publication List. On occasion however, Goods may need to be returned. Returns are governed by these Terms and Conditions.

- 17.1 The Purchaser will examine the products on delivery and will notify JSP Limited of any discrepancy or damage of any products received not in accordance to the order in writing within 14 days of receipt. "Unexamined" signatures do not relieve the Purchaser of its liability and JSP Limited shall not be responsible for any claim or claims if the Purchaser fails to comply with the provisions of this clause. If the Purchaser fails to give such notice the Goods of that delivery shall be deemed to be in all respects in accordance with the order placed and the Purchaser shall be deemed to have accepted the products and shall pay for the same accordingly.
- 17.2 If Goods are damaged in transit and the damage is apparent on delivery, the Purchaser should sign the delivery note to the effect that the Goods have been damaged. In any event, such damage should be reported to JSP Limited within 10 working days and arrange collection and return. JSP Limited is responsible for paying shipment costs. Upon receipt of the returned Goods, the price of the Goods, as paid, will be refunded through the payment method used when the Goods were purchased, i.e. a credit note on account.
- 17.3 If the Purchaser receives Goods which do not match those ordered, unless accompanied by an explanatory note detailing the changes, stating reasons for the changes and setting out your options, the Purchaser should contact us within 14 days of receipt to arrange collection and return. JSP Limited is responsible for paying shipment costs. The Purchaser will be given the option to have the Goods replaced with those ordered (if available) or to be refunded through the payment method used when the Goods were purchased i.e. a credit note on account. Refunds and replacements will be issued upon our receipt of the returned Goods.
- 17.4 If any Goods purchased have faults when they are delivered, the Purchaser should contact JSP Limited within 28 working days to arrange collection and return. JSP Limited is responsible for paying shipment costs. Goods must be returned in their original condition with all packaging and documentation. Upon receipt of the returned Goods, the price of the Goods, as paid, will be refunded through the payment method used when the Goods were purchased,

i.e. a credit note on account.

- 17.5 If any Goods develop faults within their warranty period, the Purchaser is entitled to a repair or replacement under the terms of that warranty.
- 17.6 If the Goods have been dispatched or have reached you, but the Purchaser decides that they are no longer required, the Goods can be returned to JSP Limited within 10 days of receipt. Goods can only be returned for this reason if their packaging remains unopened and the Goods can be re-sold, as new, without any additional work on the part of JSP Limited. The Purchaser is responsible for paying shipment costs if Goods are returned for this reason.
- 17.7 If the Purchaser wishes to return Goods to JSP Limited for any of the above reasons, the Goods returns must be authorised by a representative of JSP Limited and a RMA number must be obtained before the Goods are returned. Goods must be returned within 14 days from the date of when the RMA was issued. Failure to return the goods within the said period will negate further responsibility by JSP Limited.
- 17.8 If JSP Limited agrees to accept the return of Goods that are not damaged or faulty and in pristine packaging, the Customer will be responsible for the cost of carriage and will ensure that they are carefully packaged to avoid any damage in transit.
- 17.9 All returns not to be deemed the fault of JSP Limited will incur a 20% administration charge.
- 17.10 Return of orders for special order items and made to order Goods will not be accepted and must be paid in full unless faulty.
- 17.11 A credit note will only be given for returned Goods that are in saleable condition, unused, with pristine packaging and no damage or soiling unless faulty.
- 17.12 JSP Limited reserves the right to exercise discretion with respect to any returns under these Terms and Conditions. Factors which may be taken into account in the exercise of this discretion include, but are not limited to:
- 17.12.1 Any use or enjoyment that you may have already had out of the Goods;
- 17.12.2 Any characteristics of the Goods which may cause them to deteriorate or expire rapidly;
- 17.12.3 The fact that the Goods consist of audio or video recordings or computer software and that the packaging has been opened;
- 17.12.4 Any discounts that may have formed part of the purchase price of the Goods to reflect any lack of quality made known to the Customer at the time of purchase.

Such discretion to be exercised only within the confines of the law.

## 18. Privacy

- 18.1 Use of the Website is also governed by our privacy policy which is incorporated into these terms and conditions by this reference. JSP Limited will never share any of your details with a 3<sup>rd</sup> party and information provided is for the use of JSP Limited only.
